# **SLOW-NO WAKE ORDINANCE**

#### STATE OF WISCONSIN

Town of Chicog Washburn County

### Section I - Purpose

A sole ordinance to regulate boating upon the waters of all lakes located within or adjoin the Town of Chicog and prescribing penalties for violations thereof.

### Section II - Authority

The Town Board of the Town of Chicog adopts this ordinance under WI. State. 66.22 (1)

## Section III - Adoption of Ordinance

This ordinance, adopted by a majority of the Town Board of Chicog on a roll call vote with a quorum present and proper notice having been given provides for the implementation and enforcement of a Slow – No Wake policy on all waters located within of that and adjoin the Town of Chicog.

### Section IIII - Intent

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capability of the water resources.

# Section V – State Boating and Safety Laws Adopted

State boating laws as found in ss. 30.50 to 30.71, Wis. Stats, are adopted by reference.

#### Section VI - Definitions

"Slow – No Wake" means that the speed at which a boat moves as slowly as possible while still maintaining steerage control

# Section VII - Conditions of Issuance

No person shall operate a boat or aquatic vehicle faster than a "Slow – No Wake" in the waters of all lakes located within or that adjoin the Town of Chicog between the hours of 5:00PM – 10:00AM.

# Section VIII - Posting Requirements

The Town of Chicog shall place and maintain a synopsis of this ordinance at all public access points within the jurisdiction of the Town pursuant to the Requirements of NR 5.15 Wis.Admin. Code

### Section IX – Severability

The provisions of the Ordinance shall be deemed severable and is expressly declared that the Town of Chicog board would have passed the other provisions of this ordinance irrespective of whether one or more provisions may be declared invalid. If any provision of this ordinance or the application to any

person of circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.

# Section X - Effective Date

This ordinance shall be effective as of the date of publication in the towns official newspaper or posting in accordance with Wis. Stats. 60.80.
