

**HIGHWAY ORDER DISCONTINUING YELLOW BANK ROAD PURSUANT TO  
§§ 82.10 *et seq*, STATS.**

The Chicog Town Board Finds and Orders as follows:

1. Yellow Bank Road has not been the subject of expenditure of public funds for more than five years and is not currently open for vehicular travel. The roadbed is overgrown.

2. The legal description Yellow Bank Road of the discontinued is:

**Yellow Bank Road as presently laid out whose centerline commences at its intersection with the centerline of Burian Place Road 707.88'± West of the Section corner of Sections Sixteen (S16), Seventeen (S17), Twenty (S20) and Twenty-One (S21), along the Quarter Section Line lying between Sections Seventeen (S17) and Twenty-One (S21) of Township Forty-One North (T41N) of Range Thirteen West (R13W) in the Town of Chicog, Washburn County, Wisconsin; thence Southeasterly± through the Northeast Quarter of the Northeast Quarter (NE/NE) of the stated Section Twenty (S20), to a point at its intersection with the North-South Section Line lying between the Northeast Quarter of the Northeast Quarter (NE/NE) of the stated Section Twenty (S20) and the Northwest Quarter of the Northwest Quarter (NW/NW) of Section Twenty-One (S21), 946.20'± South of that Line's intersection of the stated Sections Sixteen (S16), Seventeen (S17), Twenty (S20) and Twenty-One (S21); thence Southerly± along the stated North-South Section Line between the Northeast Quarter of the Northeast Quarter (NE/NE) of Section Twenty (S20), the Northwest Quarter of the Northwest Quarter (NW/NW) of Section Twenty-One (S21) and thence between the Southeast Quarter of the Northeast (SE/NE) of Section Twenty (S20) and the Southwest Quarter of the Northwest Quarter (SW/NW) of Section Twenty-One (S21), a distance of 658.00' to the end point. Together with a 4-rod right-of-way. PINs 65-016-2-41-13-20-1 01-000-001000; 65-016-2-41-13-20-1 01-000-003000; 65-016-2-41-13-20-1 01-000-002000; 65-016-2-41-13-20-2 02-000-001000; 65-016-2-41-13-20-2 03-000-001000**


3. Section 82.19(2)(a), Stats., states: "Every [town] highway shall cease to be a public highway 4 years from the date on which it was laid out, except the parts of the highway that have been opened, traveled, or worked within that time."
4. Section 82.19(2)(b)2., Stats., states: "Any highway that has been entirely abandoned as a route of vehicular travel, and on which no highway funds have been expended for 5 years, shall be considered discontinued."
5. The Chicog Town Board finds that both statutory definitions inactivity have been met and that Yellow Banks Road is discontinued by operation of law.

6. A public hearing of this resolution was held this date at the December 14, 2022, meeting of the Chicog Town Board.
7. Timely notice of such hearing was rendered.
8. The notice of the public hearing was published in the Spooner Advocate as a Class III notice in timely fashion pursuant to § 89.10, Stats.
9. A *lis pendens* regarding the action taken this day was filed with the Washburn County register of deeds on November 28, 2022, as Document Number 405159, pursuant to §§ 82.10(5) & 840.11(1), Stats.
10. This action formalizes the status of Yellow Bank Road.

**NOW, THEREFORE, BE IT RESOLVED, that**

1. Yellow Bank Road as described is formally discontinued in its entirety and a highway order shall issue and be recorded with proper notice to the required parties.
2. The *lis pendens* found at Document Number 405159, register of deeds, is hereby released.

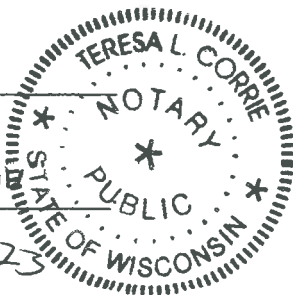
