RESOLUTION OF THE TOWN OF CHICOG VACATING AND DISCONTINUING A CERTAIN ROAD

WHEREAS, the following described road in the Town of Chicog, County of Washburn, State of Wisconsin is platted; and

WHEREAS, the Town Board has received an application to discontinue the road pursuant to Wisconsin Statutes § 82.10;

WHEREAS, it is deemed necessary, and in the public interest to vacate and discontinue said road;

WHEREAS, the Town Board is satisfied that the notices required in Wisconsin Statutes § 82.10 (4) have been given; and

WHEREAS, the Town Board has recommended the vacating and discontinuance of said road;

NOW, THEREFORE, BE IT RESOLVED, that the public interest requires that the following described road located within the Town of Chicog be vacated and discontinued, subject only to utilities, sewer, easements and usage existing thereon, future construction and maintenance rights and access, including access rights incidental to such easements and usages:

Within that part of the Northeast Quarter of the Northeast Quarter (NE¼ of NE¼), and that part of the Northwest Quarter of the Northeast Quarter (NW¼ of NE¼), Section Seven (7), Township Forty-one (41) North, Range Twelve (12) West, Commencing from The Northeast Corner Of Section 7:

Thence S41°17'37"W 1341.00' More Or Less To The Intersection Of The Centerlines Of 'Ranch Drive' & 'Roebke Road' Being The Point Of Beginning;

Thence N47°47'18"W 36.79' Along The Said Centerline Of 'Roebke Road';

Thence Northwesterly 152.69' Along Said Centerline Of 'Roebke Road' Being The Arc Of A Circle Concave To The Southwest Having A Radius Of 238.00° And A Chord Which Bears N 66°10'05"W 150.09';

Thence N84°32'53"W 258.27' Along Said Centerline Of 'Roebke Road' To A Point On The East Sixteenth Line Of The Northwest Quarter Of The Northeast Quarter;

Thence N89°50'55"W 532.00' Along Said Centerline Of 'Roebke Road';

Thence Northwesterly 134.75' Along Said Centerline Of 'Roebke Road' Being The Arc Of A Circle Concave To The Northeast Having A Radius Of 380.00° And A Chord Which Bears N79°41'23"W 134.05';

IT IS FURTHER RESOLVED, that upon recording of this Resolution and the aforementioned Highway Order, the *lis pendens* filed with the Washburn County Register of Deeds regarding the aforementioned road shall be released.
